Unfortunately, there has been sickness with my family in Brazil, and I have been out of the country in Sao Paulo, Brazil, for several months.

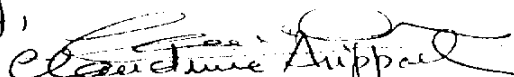
