The undersigned incorporator hereby forms a corporation under the laws of the State of Florida.

**ARTICLE I NAME**

The name of the corporation is **Star Graphics Group, Inc.**

**ARTICLE II ADDRESS**

**ARTICLE III COMMENCEMENT OF CORPORATE EXISTENCE**

The corporation's existence will commence **February 9, 1996**; provided however, that such date is within five business days prior to the date these Articles of Incorporation are filed by the Department of State of the State of Florida.
