ARTICLES OF INCORPORATION OF

PRINCESS ENTERTAINMENT CRUISES, INC.

Article I - Name

The name of this corporation is PRINCESS ENTERTAINMENT CRUISES, INC. and its principal office is located at 1970 Michigan Avenue, Building C, Cocoa, FL 32923-1888.

Article II - Duration
