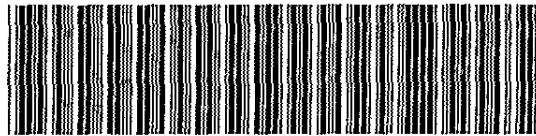

Article I Articles of Incorporation:

The Articles of incorporation were filed on February 12th, 1996 under document number P960000147157. An amendment to the articles was made June 6th, 1996 to with Principle place of Business under the document number P960000147157. Then on January 6th, 2003 the Corporation changed its name to Provident Capital Funding Corp. from Atlas Mortgage Corporation.

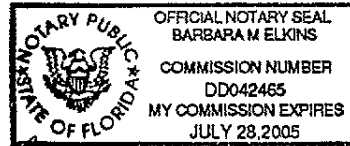
