NAME OF CORPORATE ENTITY: The name of the corporation shall

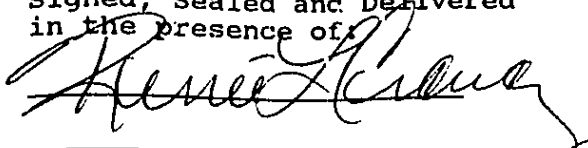

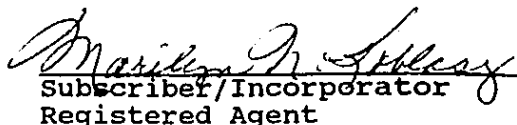
