the Florida General Corporation Act.


ARTICLE X - INDEMNIFICATION

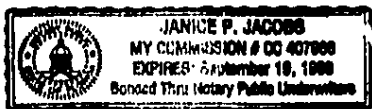


