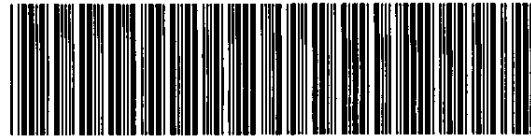




**THEREFORE IT WAS RESOLVED** that these Articles of Dissolution be filed with the Florida Department of State Division of Corporations.


