CAPITAL STOCK

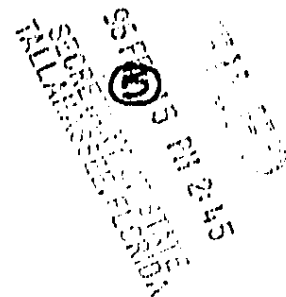
This corporation is authorized to issue 7,500 shares of One Dollar (\$1.00) par value common stock.

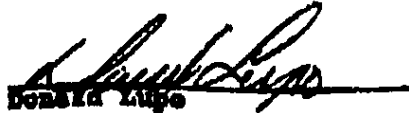

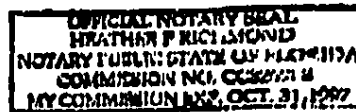
