ARTICLES OF INCORPORATION

OF

BAHIA ELECTRONICS, INC.

Article I - Name

The name of this corporation is :

BAHIA ELECTRONICS, INC.

Article II - Duration

This Corporation shall exist perpetually unless dissolved according to law and such existence shall commence at the time of the filing of these Articles of Incorporation by the Department of State.

Article III - Purpose

The Corporation may engage in any legal activity.
