Articles of Incorporation

We, the undersigned, being natural persons of legal age, do hereby desire to form a corporation under the laws of the State of Florida, and do hereby adopt these following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be JHD Enterprise, Inc.

ARTICLE II OFFICE AND ADDRESS

The principal office of the corporation and its mailing address shall be 2904 South Orange Blossom Trail, Orlando, Florida, 32805, in Orange County. These may be changed from time to time by the Board of Directors.

ARTICLE III STOCK

The maximum number of shares of stock of this corporation which it is authorized to have outstanding at any one time is Two Hundred Eighty Four (284) shares of common stock having a par value of One Thousand Dollars (\$1,000.00) per share. The consideration to be paid for each share of stock shall be fixed by the Board of Directors of this corporation.

ARTICLE IV REGISTERED OFFICE & AGENT

The street address of the initial registered office of this corporation is 2904 South Orange Blossom Trail, Orlando, Florida, 32805, in Orange County, and the initial registered agent of this corporation at that address is JITENDRAKUMAR C. Patel, whose residence address is the same.

ARTICLE V DIRECTORS

The business of the corporation shall be conducted and managed by a Board of Directors consisting of not less than two members, as fixed from time to time by the By-Laws of the corporation. The Directors shall be elected or appointed as provided in the By-Laws.

ARTICLE VIII BY-LAWS

The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors.

ARTICLE IX INDEMNIFICATION


Every Director, Officer, employee or agent of the Corporation shall be indemnified by the Corporation against all expenses and liabilities, including attorneys fees reasonably incurred or by reason of their being imposed upon him or her, in connection with any proceeding to which he or she may be made a party or in which he or she may become involved by reason of his or her employment or by reason of his or her being or having been a Director, Officer, employee or agent of the Corporation, or any settlement thereof, whether or not he or she is a Director, Officer, employee or agent at the time such expenses are incurred, except in such cases wherein the Director, Officer, employee or agent is adjudged liable for gross negligence or willful and wanton misconduct in the performance of his or her duties as such Officer, Director, employee or agent. The foregoing right of indemnification shall be in addition to and not exclusive of all other rights to which such Director, Officer, employee or agent may be entitled.

ARTICLE X AMENDMENT

The Corporation reserves the right to amend, alter, change, repeal and revise any of the provisions of this Corporation's Articles of Incorporation in the manner now, or hereafter prescribed by statute and all rights conferred on shareholders herein are granted subject to this reservation.
