The undersigned incorporator, a natural person over the age of eighteen (18) years, hereby adopts, subscribes, acknowledges, executes and files the following Articles of Incorporation for the purpose of forming a corporation for profit under the Florida Business Corporation Act and the laws of the State of Florida.

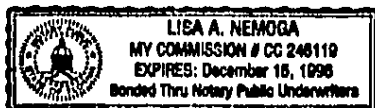




