WE, the undersigned, for the purposes of forming a corporation for profit pursuant to the laws of the State of Florida, do hereby adopt the following Articles Of Incorporation:

ARTICLE I

NAME



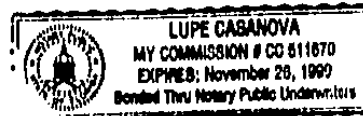

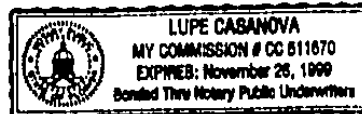
