The undersigned, for the purpose of foregoing a corporation under the Florida general corporation act, do hereby adopt the following Articles of Incorporation.

ARTICLE I

Corporate Name and Address

The name of the corporation is Scott Teitler Photography, Inc. located at 120 S.W. 91st Avenue, Apartment # 107, Plantation, FL 33324.

ARTICLE II

Term of Existence

The duration of the corporation is perpetual, to be commenced with the filing of these Articles of Incorporation with the Department of State within the State of Florida.

ARTICLE III

Nature of the Corporate Business

The general purpose for which the corporation is organized is:

- 1.) To provide photography services and to do such things which are related and incidental to the foregoing, or necessary, or desirable in order to accomplish the foregoing and;
- 2.) To transact any other lawful business for which corporations may be incorporated under Florida law.

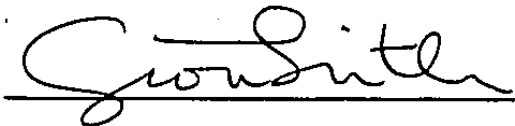

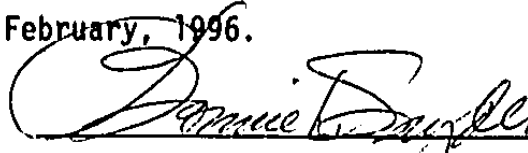

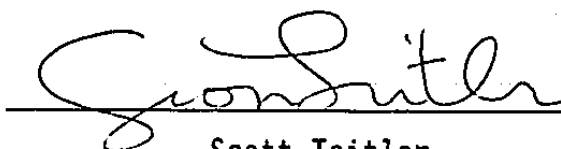
