## ARTICLES OF INCORPORATION of DHARMA BLUE, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE 1 - Name. The name of the corporation is DHARMA BLUE, INC.

<u>ARTICLE II - Purpose</u>. Corporate Purpose and Powers. This corporation is initially organized for the transaction of any and all lawful business for which corporations may be incorporated under Chapter 607.011 of the Florida Statutes. This corporation shall have all corporate powers enumerated in said Chapter 607.011.

ARTICLE III - Capital Stock The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is one thousand (1000) shares of common stock. Such shares shall be of a single class, and shall have a par value of one dollar (\$1.00) per share. Stock shall be issued under Section 1244 of the Internal Revenue Code.

<u>ARTICLE IV. Initial Capital</u>. The amount of capital with which the corporation will begin business shall not be less than \$500.00.

ARTICLE V. Duration. The corporation shall have perpetual existence.

ARTICLE VI - Principal Office The street address of the principal office of this corporation in this state is 420 East Pine Avenue, Crestview, Florida 32539, and the mailing address is P.O. Box 727, Crestview, Florida 32536.

ARTICLE VII - Initial Registered Office and Agent. ARTICLE VIII - Management by Shareholders.
