ARTICLES OF INCORPORATION OF

ARTICLE 11. - NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation shall be:

- (a) To engage in the providing of professional services relating to computer programming for various types of computer hardware, providing software packages for sale & distribution to & for all types of commerce & industry & for export & to sell & distribute all types of computer hardware & accessories & to engage in any & all other functions, services and/or activities considered necessary, incidental, proper and/or ancillary, thereto, and to do all other things which may be desirable to achieve the purposes aforesaid and to operate a successful business.
