

The name of the corporation is NORTH AMERICAN SECURITY SYSTEMS, INC.

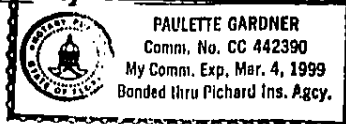
