ARTICLES OF INCORPORATION OF

BIJUE MOUNTAIN TRUCKING COMPANY, INC. 8627 BEEKMAN DRIVE MIRAMAR, FLORIDA 33025

ARTICLE T

The name of the corporation is <u>BLUE MOUNTAIN TRUCKING</u> COMPANY, INC.

ARTICLE II - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.
