



The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

NAME

The name of the corporation is SAN Carlos PROPERTY RENTALS INC. (hereinafter called the "Corporation".)

ARTICLE, II

PRINCIPAL OFFICE

The principal place of business and Mailing address of this Corporation is 17410 W. Carnegie Circle, Fort Myers, FL 33912.

ARTICLE III

PURPOSE

The Corporation Is organized for the purpose of transacting any and all lawful business for corporations organized under the General Corporation Act of the State of Florida.

The aggregate number of shares which the Corporation shall have the authority to issue is One Hundred Shares (100) shares of Common Stock, having a "par value of one dollar" per share.

ARTICLE V

INITIAL REGISTERED OFFICE AND AGENT

AMENDMENT


