

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation is TREVOR SINGER, P.A.

ARTICLE II - PURPOSE

This corporation is organized for the purpose of transacting all business permitted under the real estate laws of the State of Florida and the United States of America. ARTICLE XI - SUB-CHAPTER S CORPORATION


This corporation may elect to be treated as a Sub-Chapter S Corporation as defined by the Internal Revenue Code.

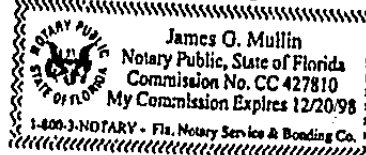
