ARTICLES OF INCORPORATION OF GOKIA CONSTRUCTION CORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I

The name of this corporation is GOKIA CONSTRUCTION CORPORATION.

ARTICLE II PURPOSE
