ARTICLES OF INCORPORATION
OF

ARTICLE I - Name

The name of the corporation is PAUL & JANET ENTERPRISES, INC.

ARTICLE II - Duration

This corporation shall have perpetual existence commencing on the date of execution and acknowledgment of these Articles or until such time as it shall be dissolved by law.

ARTICLE III - Purpose

This corporation is organized for the purpose of transacting any and all business not unlawful under the laws of the State of Florida or the United States.

ARTICLE IV - Capital Stock

This corporation is authorized to issue One Thousand (1000) shares of One Dollar (\$1.00) par value common stock, which shall be designated "common shares". Any and all such "common shares" shall be one class only.

ARTICLE V - Pre-Emptive Rights

Every share holder upon the sale for cash for any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof at the price at which it is offered to others.

ARTICLE VI - Initial Board of Directors

This corporation shall have two directors initially. The number of directors may be either increased or diminished from time to time by by-laws adopted by the shareholders, but shall never be less than the minimum number of directors required by law. The names and addresses of the initial directors of this corporation are: PAUL J. JOHNSON, 2144 Copley Drive, Pensacola, Florida 32503; and JANET L. JOHNSON, 2144 Copley Drive, Pensacola, Florida 32503.

ARTICLE VII - Incorporations

ARTICLE VIII - Initial Registered
Office, Principal Office and Agent

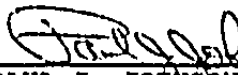
ARTICLE IX - By-Laws

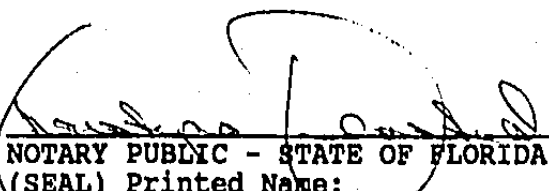
