ARTICLES OF INCORPORATION OF

DYNAVEND, INC.

FILED

Article I Name. The name of the corporation is: DYNAVEND, INC.

Article II Principal Office and Mailing Address. The street address and mailing address of the principal office is: 2910 S.E. 3rd Court, Ocala, Fiorida 34471.

Article III Shares. The corporation is authorized to issue One Hundred (100) shares. The par value is \$1.00 per share. Each share of stock shall be entitled to one vote, and in the election of directors of the corporation, the holders of the stock shall be entitled to vote their stock cumulatively.

Article IV Preemptive Rights. Each shareholder of this corporation shall have the first right to purchase shares of any class, kind, or series of stock in this corporation that may from time to time be issued, whether or not presently issued, including shares from the treasury of this corporation, in the ratio that the number of shares he holds at the time of issue bears to the total number of shares outstanding, exclusive of treasury shares.
