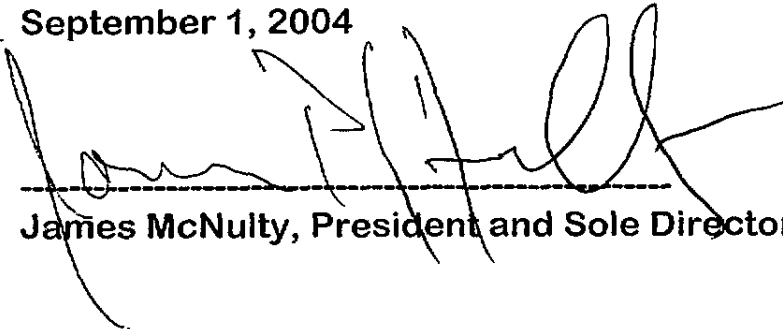
**THE UNDERSIGNED, being the sole director and president

shall be Holoco Inc.**

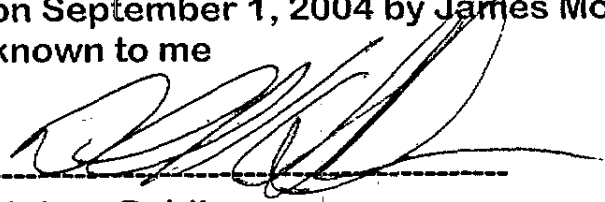

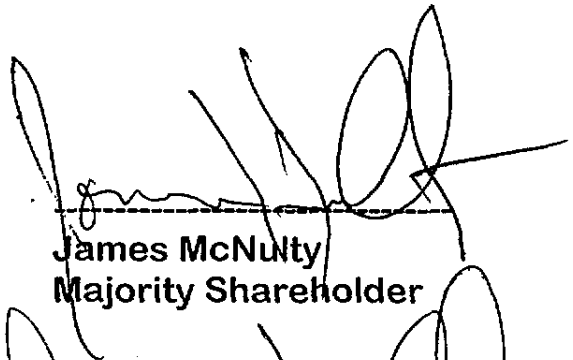

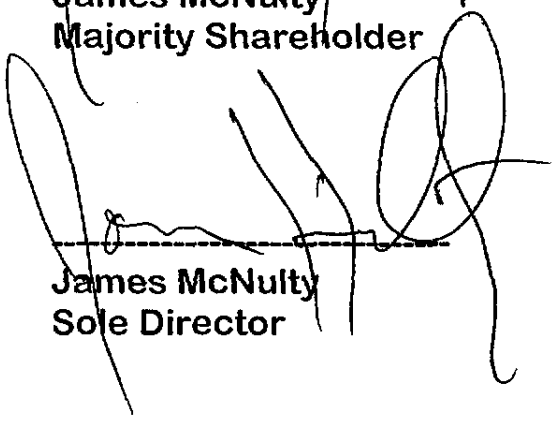
**CONSENT OF ACTION OF THE MAJORITY SHAREHOLDER AND
