**ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS**

The name of this corporation is **SHADOW INVESTIGATIONS, INC.**, and its principal place of business shall be located at 2500 Winding Creek Blvd., #E-208, Clearwater, Florida 34621.

**ARTICLE II - DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of transacting any and all lawful business.

**ARTICLE IV - CAPITAL STOCK**

This corporation is authorized to issue One Thousand (1,000) shares of common stock at One Dollar (\$1.00) par value, which shall be designed as "Common Shares".
