ARTICLES OF INCORPORATION

The Undersigned who is duly licensed to practice Podiatric Medicine in the State of Florida desires to form a professional corporation under the Laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida, and the Florida Professional Service Corporation Act providing for the formation, liability, rights, privileges and immunities of a corporation for profit, and do hereby adopt the following Articles of Incorporation:

ARTICLE ONE

NAME

The name of the corporation is RICHARD STRAUSS, D.P.M., P.A.. The address of the principal office of this corporation shall be 309 East Hallandale Beach Boulevard, Hallandale, Florida 33009, and the mailing address of the corporation shall be the same.

ARTICLE TWO

DURATION

The term of existence of the corporation is perpetual.

### ARTICLE THREE

#### PURPOSE

The corporation will be permitted to engage in every phase and aspect of the business of rendering professional services to the public in the practice of Podiatric Medicine, within the State of Florida, and to take all actions that are necessary or proper in connection with that practice. This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation. In addition, the corporation may transact any and all lawful business for which corporations may incorporate under the Florida General Corporation Act and the Professional Service Corporation Act. Whenever the provisions of these two Acts conflict, the Professional Service Corporation Act will control.

### ARTICLE FOUR

#### CAPITAL STOCK

The aggregate number of shares which the corporation has authority to issue is five thousand (5,000), all of which shall be common shares with a par value of One Dollar (\$1.00)

#### ARTICLE FIVE

##### PRE-EMPTIVE RIGHTS GRANTED

Each shareholder of any class of stock of this corporation shall be entitled to full pre-emptive rights to purchase any unissued or treasury shares of the corporation and any securities of the corporation convertible into or carrying a right to subscribe to or acquire shares of any such unissued or treasury shares.

#### ARTICLE SIX

##### REGISTERED OFFICE

The street address of the initial registered office of the corporation is 309 East Hallandale Beach Boulevard, Hallandale, Florida 33009, and the name of the initial registered agent at such address is Richard Strauss.

#### ARTICLE SEVEN

##### DIRECTORS

The initial Board of Directors of the Corporation shall consist of one (1). The number of Directors is to be set by the Shareholders at a meeting called for that purpose. The names and addresses of the first Board of Directors are:

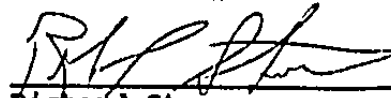
