I, the undersigned, do hereby execute these Articles of Incorporation for the purpose of forming a professional service corporation under the Florida Professional Service Corporation Act, and hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME AND PRINCIPAL OFFICE

The name of this corporation is: CHARLES HELFELD, DC, PA

ARTICLE II - DURATION

The corporation shall have perpetual existence.

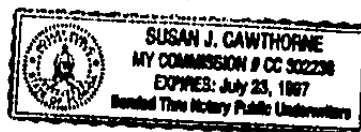

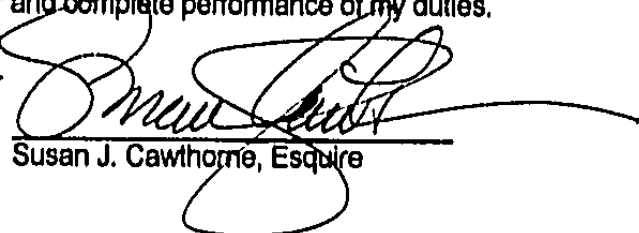
