# ARTICLES OF INCORPORATION OF MAI MICHELLE, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

## ARTICLE I (Name and Mailing Address)

The name of the corporation is MAI MICHELLE, INC., and its mailing address is 2278 First Street, Fort Myers, Florida 33901.

### ARTICLE II (Duration)

The duration of this corporation is perpetual and its existence shall commence on the date of execution and acknowledgment of these Articles.
