The Undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopt the following articles of incorporation for such corporation:

1. The name of the corporation is OUTDOOR CONCEPTS, INC. and the initial principal address of the corporation is 287 Oak Park Place, Casselberry, Florida 32707.
2. The period of its duration is perpetual. The corporate existence of the corporation shall commence upon the filing of these Articles of Incorporation with the Secretary of State of the State of Florida.
3. The purpose or purposes for which the corporation is organized are to engage in any activity or business permitted under the laws of the United States and of the State of Florida.
4. The corporation shall have the authority to issue 7500 shares, all of one class, one dollar par value.

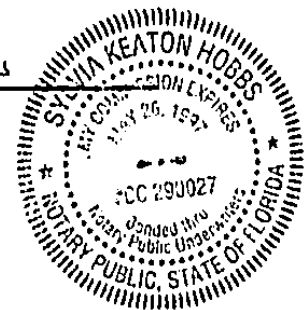

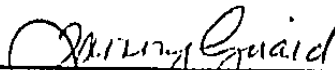

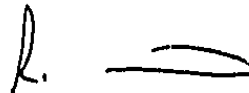
