ARTICLES OF INCORPORATION  
OF  
HOMETOWN U.S.A. INSURANCE AGENCY, INC.

ARTICLE I: Name

HOMETOWN U.S.A. INSURANCE AGENCY, INC.

ARTICLE II: Duration

This corporation shall exist in perpetuity commencing on the date of execution and acknowledge of these articles.

ARTICLE III: Purpose

This corporation is organized for the purpose of transacting any and all lawful business, including, but not limited to the following: wholesale, retail, franchise, and any other business as allowed by law.

ARTICLE IV: Capital Stock

This corporation is authorized to issue One thousand (1,000) shares of Ten cents (.10) par value common stock which shall be designed "Common Shares".

ARTICLE V: Preemptive Rights

Each shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as the he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

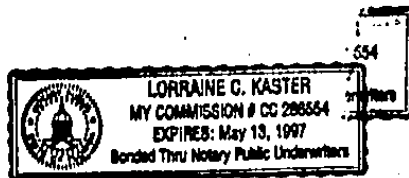
