ARTICLES OF INCORPORATION of BAREFOOT TRACE RENTALS, INC.

These Articles of Incorporation are executed by the undersigned for the purpose of forming a corporation pursuant to the Florida General Corporation Act, as particularly set forth in Chapter 607 of the Florida Statutes.

ARTICLE I. NAME

The name of this corporation shall be Barefoot Trace Rentals, Inc.

ARTICLE II. PRINCIPLE OFFICE
