**ARTICLES OF INCORPORATION
of
BAREFOOT TRACE RENTALS, INC.**

These Articles of Incorporation are executed by the undersigned for the purpose of forming a corporation pursuant to the Florida General Corporation Act, as particularly set forth in Chapter 607 of the Florida Statutes.

**ARTICLE I.
NAME**

The name of this corporation shall be Barefoot Trace Rentals, Inc.

**ARTICLE II.
PRINCIPLE OFFICE**

The principle place of business and mailing address of this corporation shall be at:

St. Augustine, FL 32084
or such other location as time to time determined by the board of directors.

**ARTICLE III.
DURATION**

The corporation shall commence upon the filing of these Articles and shall have perpetual existence thereafter.

**ARTICLE IV.
PURPOSE**

The purpose for which the corporation is organized is the transaction of rental and sales programs for the Barefoot Trace Condominium located in the County of St. Johns, St. Augustine, Florida and any and all other lawful business for which a corporation may be incorporated under the Florida General Corporation Act, as the same may from time to time be amended.

**ARTICLE VII.
PREEMPTIVE RIGHTS**

Directors of the corporation have the power to approve shareholders and remaining holders (if any) of the initial stock offering reserve the right of first refusal on all stock sales or exchanges. BYLAWS**


