ARTICLE I - NAME AND ADDRESS

The name and mailing address of the Corporation is Intersky Inc. and 5445 Collins Avenue, Apartment No. L-1, Miami Beach, Florida 33140 respectively.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.

ARTICLE IV - CAPITAL STOCK
