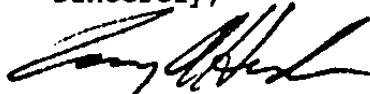

ARTICLES OF INCORPORATION

The undersigned subscribers to these Articles of Incorporation, each a natural person, competent to contract, hereby execute these Articles for the purpose of forming a corporation under the Laws of the State of Florida.

ARTICLE I.

NAME

The name of this corporation is **Concepts 2000, Inc.**

ARTICLE II.

NATURE OF BUSINESS

The general nature of this business and the objects and purposes proposed to be transacted and carried on are:

To do any and all of the things herein mentioned as fully and to the same extent as natural persons might or could do, to-wit:

To create new ideas and inventions, to patent the same and to manufacture,

produce and market the same.

To take, acquire, buy, hold, own, maintain, work, develop, sell, convey, lease, mortgage, exchange, and improve, and otherwise deal in and dispose of real estate and real property and all other kinds of property of any nature whatsoever, whether real, personal or mixed, or any interest or rights therein without limits as to amounts; to buy and sell, convey, assign and cancel liens upon personal property and real estate of every kind, class or nature; to draw, acquire, enforce, discount and deliver bills of exchange, promissory notes, bonds debentures and other negotiable instruments of any kind, class, or nature, and secure the same by mortgage on its property or otherwise; to issue on commission, subscribe for, take, acquire, hold, exchange and dealing shares, stocks, bonds, obligations, or securities of any government, or authority, individual or corporation.

Generally, to make and perform contracts of any kind or description, and for the purpose of attaining any of the objects of the corporation, to do and perform any other acts or things to exercise any and all powers which a copartnership or natural person could do and/or exercise, and which now or thereafter may be authorized by law, and generally to do and perform all things necessary or incident to the performing and carrying out of the powers hereinabove specifically delegated or implied, provided, however, that no provision hereinabove set forth shall be construed to authorize this corporation to conduct

a banking, safety deposit, trust, insurance surety, express, railroad, canal, telegraph, telephone or cemetery company, a building and loan association, or a mutual fire insurance association business or cooperative associate, or fraternal benefit society, or state fair or exposition.

ARTICLE III.

CAPITAL STOCK

The maximum number of shares of stock this corporation is authorized to have outstanding at any one time is ten thousand (10,000) shares of common stock with a nominal or par value of TEN DOLLARS (\$10.00) DOLLARS, per share.

ARTICLE IV.

PREEMPTIVE RIGHTS

The stockholders of this corporation shall have preemptive rights in and to all additional shares that might be authorized by the corporation in proportion to the number of shares owned of the original issued to the corporation.

ARTICLE V.

TERM OF EXISTENCE

This corporation is to exist perpetually, and shall commence existence as of the filing of these Articles with the Department of State of the State of Florida.

ARTICLE VI.

REGISTERED OFFICE AND RESIDENT AGENT

The registered office of the corporation shall be located at 215 Southeast Pinckney Street, Madison, Florida, and the registered agent of the corporation is Cary A.
