The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

ARTICLE 1

NAME AND ADDRESS

Section 1.1 **Name.** The name of the corporation is International Transport Logistics, Inc.

DURATION

Section 2.1 **Duration.** This corporation shall exist perpetually. 
