ARTICLES OF INCORPORATION

OF

ACAPULCO MEXICAN RESTAURANT, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, dons hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporation is: ACAPULCO MEXICAN RESTAURANT, INC.

Article 2. Address of the Principal Office. The address of the corporation is 1835 U.S. 1 South, Suite 135, St. Augustine, Florida 32086.

Article 3. Purpose. The general purposes for whom the Corporation is organized are the following:
