ARTICLES OF AMENDMENT OF MEDICAL ASSOCIATES OF BREVARD, P.A.

Pursuant to Section 621.13(4), Florida Statutes, Medical Associates of Brevard, P.A. hereby submits these Articles of Amendment to its Articles of Encorporation, intending to change its business purpose from the rendering of professional medical services to a purpose which includes any lawful purpose. In changing its purpose from rendering professional medical services to any other lawful purpose, Medical Associates of Brevard, P.A. intends that it shall be governed pursuant to the provisions of Chapter 607, Florida Statutes.

- I. The name of this Corporation is Medical Associates of Brevard, P.A.
- II. The Articles of Incorporation of Medical Associates of Brevard, P.A. are amended as follows:
- A. The first paragraph of the Articles of Incorporation of Medical Associates of Brevard, P.A. is deleted in its entirety and replaced with the following: "The undersigned hereby submits these Articles of Incorporation to the Florida Secretary of State."
- B. Article I of the Articles of Incorporation is amended to change "MEDICAL ASSOCIATES OF BREVARD, P.A." to "MEDICAL ASSOCIATES OF BREVARD, INC.".
- C. Article II of the Articles of Incorporation is deleted in its entirety and replaced with the following:

"ARTICLE II PURPOSE

The Corporation is authorized to engage in any lawful business authorized under the laws of the State of Florida."

D. Article III of the Articles of Incorporation is deleted in its entirety and replaced with the following.

"ARTICLE III CAPITAL STOCK

This Corporation shall have one class of stock. The Corporation is authorized to issue 10,000 shares of common stock, par value \$0.10."

- III. This Amendment was adopted on the 25th day of April, 2005.
- IV. The Shareholders of the Corporation approved these Articles of Amendment by a unanimous vote which was sufficient for approval. The Corporation has a single class of stock.
