THE UNDERSIGNED, PHILLIP H. TAYLOR, President, of Taylor & Swope, P.A., a Florida corporation (the "Corporation"), for and on behalf of the Corporation, hereby executes these Articles of Amendment to the Articles of Incorporation:

ARTICLE FIRST: The current name of the Corporation is Taylor & Swope, P.A..

ARTICLE SECOND: The Amendment to the Articles of Incorporation of the Corporation effected by these Articles of Amendment is that ARTICLE I of the current Articles of Incorporation is amended to provide as follows:

ARTICLE I

The name of this corporation is Law Offices of Phillip H. Taylor, M.D., J.D., P.A.

ARTICLE THIRD: The amendment to the Articles of Incorporation of the Corporation reflected in ARTICLE SECOND hereof was duly adopted by the shareholders of the Corporation by unanimous written consent, executed on February 10, 1998, in accordance with Sec. 607.0704 of the Florida General Corporation Act.
