ARTICLE I - NAME AND ADDRESS

The name of this corporation is Stan's Automotive Repair, Inc.  
The address of the principal office is 2060 - 20th St., Sarasota,  
Florida 34234.

ARTICLE II - TERM

This corporation shall commence to exist on February 14, 1996,  
and shall exist perpetually or until legally dissolved.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of engaging in the  
conduct of automotive repair and any or all lawful business, and  
doing all acts and things as are incidental to the foregoing pur-  
poses or necessary or convenient to carry on the business for the  
business for the corporation or to effect or promote the purposes  
for which the corporation is formed.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue one thousand (1000) shares  
of stock at a par value of one dollar (\$ 1.00) per share.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this cor-

ARTICLE VI - MANAGEMENT OF CORPORATION BY SHAREHOLDERS

All corporate powers shall be exercised by or under the authority of this corporation; and business and affairs of the corporation shall be managed under the direction of the shareholders of this corporation. This corporation shall have no directors.

One hundred percent (100%) of the share entitled to vote, represented in person or by proxy, shall constitute a quorum at a meeting of the shareholders. If a quorum is present, the affirmative vote of fifty-five percent (55%) of the shares represented at the meeting and entitled to vote on the subject matter shall be the act of the shareholders.

ARTICLE VII - INCORPORATOR

The name and address of the person signing these Articles is Stan Driggers, 2308 - 22nd Avenue W., Bradenton, Florida 34205.

ARTICLE VIII - AMENDMENT

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment thereto, and any right conferred upon the shareholders is subject to this reservation.

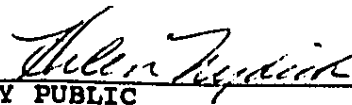

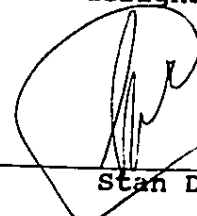
