ARTICLE I

The name of this corporation is GLASSLOCK PROTECTIVE SYSTEMS, INC.

ARTICLE II

This corporation shall exist in perpetuity.

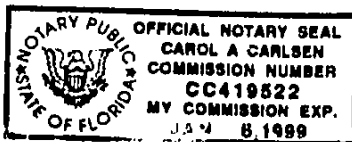
