The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

Corporate Name and Principal Office

The name of this corporation is Prepaid Teleservices, Inc. and its principal office and mailing address is 2111 N. 15th Street, Tampa, Florida 33605.

ARTICLE II

Commencement of Corporate Existence

The corporation shall come into existence on February 16, 1996.

ARTICLE III

General Nature of Business

The corporation may transact any lawful business for which corporations may be incorporated under Florida law.

ARTICLE IV

Capital Stock

By-Laws


