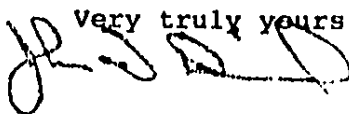

The name of this corporation is Al-N-ME, Inc.

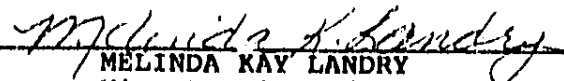

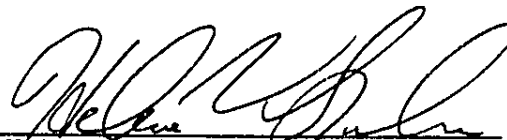

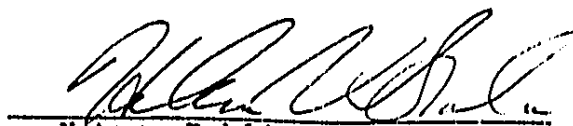
