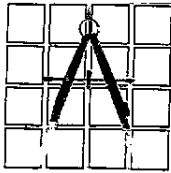

ARTICLES OF INCORPORATION OF

1. The name of the corporation is Angewise Corporation (a corporation).
2. Article I of the Articles of Incorporation of the corporation is amended to read as follows:

ARTICLE I – NAME

The name of the corporation is:
Angewise Corporation

This company "Angewise Corporation" shall have two different divisions as stated below. The number of divisions may either increase or decrease from time to time, but shall never be less than one. Each division is solely separate from each other and solely responsible for there own Divisions.

1. **Angewise, Inc. Land Surveyors** will provide Land surveying services
2. **Angewise Interior Design** will sell furnishings

On July 23, 2000 Ms. Juliann M. Bonello was removed as Secretary from the corporation and Marcus Faller was reelected as Secretary of the corporation.

This Amendment was recommended by the board of directors to the corporation's shareholders on July 23, 2000.

This Amendment was approved by the holders of a majority of the Corporation's common stock, which is the only group of the Corporation's shareholders entitled to vote on the Amendment, and the number of votes in favor of the Amendment was sufficient for approval.
