SECTION 9.01 *To engage in every aspect and phase of the business of:
Any and all business which is not contrary to the laws of the United States of America and of the State of Florida.*

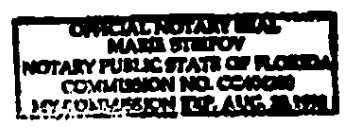
