The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation.

**ARTICLE I
CORPORATION NAME**

The name of this corporation is **The MILCURALL Group, Inc.**

**ARTICLE II
ADDRESS OF INITIAL PRINCIPAL OFFICE AND MAILING ADDRESS**

The street address of the initial principal office of this corporation shall be **309 N.E. 1st Street, Gainesville, Florida 32601**. The mailing address of the corporation is **P.O. Box 5383, Gainesville, FL 32602**. These addresses may be changed at any time by a vote of the Board of Directors.

**ARTICLE III
PURPOSE AND NATURE OF BUSINESS**

This corporation is organized for the purpose of transacting any or all lawful business, including, but not limited to the following:

- A. To engage in any lawful business permitted under the laws of the State of Florida and the United States of America.
- B. To do any and all acts and things, and to exercise any and all other powers conferred by the laws of the State of Florida upon corporations

formed under the provisions of Chapter 007, Florida Statutes, as amended, and which now or hereafter may be authorized by law.

ARTICLE IV DURATION OF EXISTENCE

This corporation shall have perpetual existence unless sooner dissolved according to law. This corporation shall commence corporate existence on the date of execution and acknowledgment of these articles.

ARTICLE V CAPITAL STOCK

A. The maximum number of shares of stock which this corporation is authorized to issue shall be Nine Hundred (900) shares, with a par value of ONE DOLLAR (\$1.00) per share, all of one class, voting common stock.

B. The consideration to be paid for each share shall be payable in lawful money of the United States of America, or in property, labor, or services which, in the judgment of the Board of Directors of this corporation, shall be of the valuation equivalent to the value of the stock to be issued; said capital stock shall be non-assessable.

ARTICLE VI INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation, and the name of its initial registered agent at that office, are Mr. C. P. Allen, 309 N.E. 1st Street, Gainesville, Florida 32601.

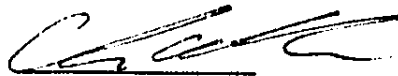
**ARTICLE VII
