I. NAME

The name of the corporation is FIRST FLORIDA GROUP,

II. TERM OF EXISTENCE

X. AMENDMENTS

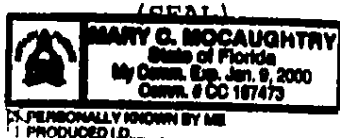
