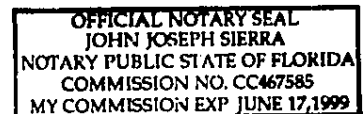

The name of the Corporation is changed from EDUCATIONAL VISIONS, INC. OF TAMPA BAY to TECHSOL, INC.


