THE UNDERSIGNED, acting as the Incorporator of a corporation Aut," adopts the following Articles of Incorporation for such Corporation.

CORPORATE NAME EUGENIO VILLA ENTERPRISES INC NATURE OF CORPORATE BUSINESS

This Corporation is organized for the purpose of transacting any or all lawful business permitted under the laws of the United States and of the State of Florida.
