ARTICLES OF INCORPORATION

OF

ARTICLE I, CORPORATE NAME

The name of this corporation is PRIMA VISTA CHIROPRACTIC CENTER, INC.

ARTICLE II. NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.
