THE UNDERSIGNED, acting as incorporators of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE

The name of the corporation shall be: HEALTH SALES LIMITED, The address and malling address of the corporation's principal office shall be:

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The purpose is to engage in any activities or business permitted under the laws of the United States and of Florida.

Preemptive rights shall be as follows:
