The undersigned, acting as incorporator of **FRONTERAS INCORPORATED**, under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation (the "Corporation") is **FRONTERAS INCORPORATED**.

ARTICLE II

ADDRESS

ARTICLE III

DURATION AND COMMENCEMENT OF EXISTENCE

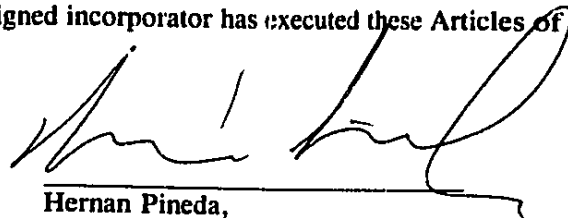

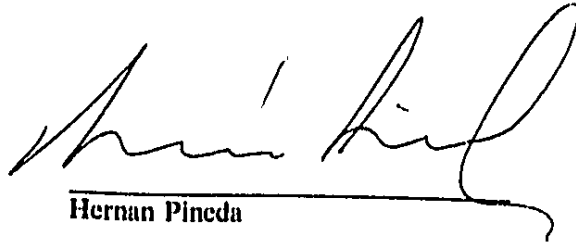
